

## INDEMNITY FOR AUTHORISATION TO ENGAGE IN FINANCIAL TRANSACTIONS FOR PRIVATE WEALTH

- (d) notify the names and titles of the person(s) authorised to receive call back confirmations from the Bank for the confirmation of information on your behalf in the form of Annex A (*Authorised Person/ Contact Details*) to this Indemnity to the Bank under clause 4.22 of the Terms.

Please arrange for each of the Annexes to be promptly completed and submitted to the Bank.

You understand that the Bank's acceptance of any Instructions is subject to the execution and provision of any documents the Bank may require and that such acceptance may be withdrawn by the Bank at any time by notice to you.
