Consent Form for Processing Personal Information¹ (for Corporate Client)

Dear Client:

Your personal information is an important basis for Sumitomo Mitsui Banking Corporation (China) Ltd. ("SMBC" or "we") to handle business and provide services. We promise to strictly comply with laws and regulations, industry regulatory regulations, and relevant agreements with you, protect your legal rights and interests in accordance with the law, and follow the principles of legality, legitimacy, minimization & necessity, integrity, openness, and transparency in the process of the Related persons' personal information. When there is a clear and reasonable purpose, we will process the personal information provided by the related persons within the scope of the processing purpose that has the least impact on their personal rights and interests.

In addition to the Consent Form, we also express to you the purpose, method, and scope of processing related persons' personal information through corresponding business (or service) agreements (such as non-disclosure agreements or confidentiality clauses), Privacy Policy (for Corporate Client) and other means to ensure your consent or authorization. The Consent Form, the corresponding business (or service) agreement, and the Privacy Policy (for Corporate Client) collectively constitute SMBC's complete privacy policy regarding the business handling and service provision to corporate clients.

¹ <u>Personal Information Protection Law of the People's Republic of China</u>, Article 4: Personal information is all kinds of information related to identified or identifiable natural persons recorded electronically or in other ways, excluding information after Data anonymization.

The processing of personal information includes the collection, storage, use, processing, transmission, provision, disclosure, deletion, etc. of personal information.

² For the purpose of the Consent Form, "Related persons" generally refers to natural persons who handle business for you, such as directors, supervisors, senior executives, controlling shareholders or actual controllers, legal representatives, persons-in-charge and authorized business handlers, etc. In addition, the services provided by us for you, including but not limited to outbound payment, transfer/remittance, etc.

If there are any changes to the purpose, method, and type of your related persons' personal information processing activities under this Consent Form, SMBC will inform you through announcements, emails and other reasonable methods. If you continue to use SMBC's services, it means you have consented to such changes.

In addition, according to relevant laws and regulations, regulatory requirements, and national standards, we do not need to obtain your authorization and consent when we collect and use your related persons' personal information in the following situations: please refer to Article 1(2) of the Privacy Policy (for Corporate Client) — "Exceptions to Obtaining Authorization and Consent" for specific situations."

2. Storage and Retention Period of Personal Information

- 1) In principle, personal information collected and generated by SMBC in the process of handling business or providing services within the territory of the People's Republic of China shall be stored within the territory of the People's Republic of China. Where it is necessary to transfer your personal information to overseas companies (such as the head office, parent or branch companies, subsidiaries, or other affiliates required to complete such business) for the reasons of handling business, we will implement legal procedures and obtain your consent in accordance with relevant laws and regulations. And we will strictly comply with relevant laws and regulations and take necessary measures to ensure the security of your related persons' personal information.
- 2) When you handle business or we provide services to you, you authorize us to continuously collect and process your related persons' personal information. When you stop handling business, withdraw your authorization, or SMBC stops providing services to you, we will stop collecting and using your related persons' relevant personal information. However, we will continue to use your related persons' personal information previously collected in areas such as business data archiving, auditing, and regulatory cooperation in accordance with laws, regulations, and regulatory requirements.
- 3) We will only retain your related persons' personal information within the minimum period required by laws, regulations, and industry regulatory authorities, as well as the purpose for which you are authorized to use it. Upon expiration of the retention period, we will delete or anonymize your related persons' personal information.

3. Providing Personal Information to Other Third Parties within the Territory of China

The circumstances and methods for SMBC to share, transfer, and publicly disclose personal information, as well as the exceptions for obtaining authorization and consent, can be found in Article 4 of the "Privacy Policy (for Corporate Client)" – "how we provide your personal information to others".

<u>For the purpose of providing services and compliance requirements</u>, we may NOT be able to provide services to you unless we provide the following your related persons' personal information to domestic third parties where necessary:

In the case of collecting minors' information with the consent of parents or legal guardians, SMBC will only process minors' personal information when it is permitted by law, explicitly agreed by parents or legal guardians, and when it is necessary to protect minors. If we found that minor's personal information had been collected without the parents' prior consent for the corporate business, we will delete such information in a timely manner.

6. Renewal of the Consent Form

In the case of any change in the relevant laws or regulations, or in the relevant business procedures or services of the SMBC or any other necessary circumstances, updated Consent Form will be publicized through our <u>WeChat official account</u>, <u>email</u>, <u>e-banking portal website etc.</u> for your confirmation, which will become effective upon your confirmation and supersede the previous relevant contents.

Annex 1: Consent Form for Handling Sensitive Personal Information
